Participant Terms and Conditions

The following Terms & Conditions apply to any person and dependents who has submitted an application for the Colour Blast Fun Run. (the "Fun Run").

DEFINITIONS

- "Shire" refers to the Shire of Yilgarn, physical address 23 Antares Street, Southern Cross WA 6426.
- "Fun Run" means the Colour Blast Fun Run to be held on Saturday 11 October 2025 from 9:30am to 12:00pm.
- **"Claims"** means all claims, liabilities, demands, suits, causes of action, damages, debts, costs, verdicts and judgments whatsoever whether at law or in equity or under any statute in connection with or arising out of the Fun Run.
- "Releasees" means the Shire of Yilgarn and any promoters, organisers, participants, sanctioning organizations, officials, rescue personnel, sponsors, advertisers, event inspectors, underwriters, consultants and any others who give recommendations or engage in risk evaluation regarding the Fun Run and the owners, occupiers and lessees of any premises used for the Fun Run and their respective directors, servants, employees and agents.

Acknowledgement and Certification

I wish to participate in the Fun Run and understand that participation has inherent risks, including risks to my personal heath (including the aggravation, acceleration or recurrence of an existing condition, contraction, aggravation or acceleration of a disease) arising from the physical nature of the Fun Run. I do so voluntarily of my own free will and at my own risk.

I am aware of the fitness level required to undertake the Fun Run and accept all risks associated with my participation in it. I will advise the Shire of Yilgarn of any pre-existing medical conditions that might reasonably be expected to increase my risk of requiring medical attention during the Fun Run.

I warrant that I am in a good state of health, that I am not receiving any medication or taking any drug which may affect or interfere with my ability to engage in the Fun Run and, other than as set out below, that I am free from any injury, medical condition (including pregnancy, heart condition or seizures), disability, disease or illness which may be aggravated by participation in the Fun Run or which may affect or interfere with my ability to engage in the Fun Run.

Waiver of Liability and Indemnification

In consideration of the Shire of Yilgarn accepting my entry into the Fun Run, to the maximum extent permitted by law I absolutely release and waive any Claim I might otherwise have against the Releasees in respect of any injury, death, loss or damage I suffer as a result of my participation in the Fun Run, howsoever arising, including as a result of any breach of contract and/or negligence by the Releasees.

To the maximum extent permitted by law I indemnify and hold harmless the Releasees against any loss or damage suffered by them as a result of any Claim made by or against me during the Fun Run howsoever arising, including as a result of any act, neglect or default caused by me during the Fun Run.

Medical Treatment and Costs

I understand that it is my responsibility to continuously monitor my own physical and mental condition during the Fun Run, and I agree to withdraw immediately and to notify appropriate personnel if at any point my continued participation would create a risk of danger to myself or to others.



In the event of an injury to me that renders me unconscious or incapable of making a medical decision, I authorise appropriate Shire personnel and emergency medical personnel at the Fun Run to make emergency medical decisions on my behalf (including, but not limited to CPR and AED).

I authorise to secure emergency medical care or transportation (St John Ambulance) when deemed necessary by Shire of Yilgarn or Event personnel and to notify my emergency contact if I am not able.

I agree to be responsible and assume liability for any and all costs incurred as a result of my participation in the Fun Run, including but not limited to ambulance transport services, hospital stays, medical care and treatment, and physician and pharmaceutical goods and services.

Media and Photography

I grant to Shire of Yilgarn and its affiliated entities or contractors and/or the media my permission and authority to use my name, image, voice, and/or likeness in any photographs, videotapes, CDs, DVDs, broadcast, telecast, podcast, webcast, recordings, motion pictures, commercial advertisement, promotion materials, and/or any other record captured during the Fun Run for any purpose whatsoever without compensation.

Personal information, including photos, is collected, held and used by Shire of Yilgarn for event coordination and administration purposes, Shire of Yilgarn event marketing and fundraising activities. Please contact us if you do not consent to Shire of Yilgarn holding and/or sharing your personal information.

Strollers, bicycles, walk-bikes

Strollers and similar devices must meet Australian Safety Standards and have appropriate safety restraints. The Shire does not take any liability concerning any claim relating to damage or loss resulting from/to those vehicles.

Please note: All Fun Run participants will be sharing the space with strollers, bicycles, walk-bikes, runners, walkers and any other forms of movement.

Pets

Due to the Fun Run being held on the Southern Cross Oval where a no dog/pet policy exists, no pets will be allowed at the Fun Run, leashed or otherwise.

Compliance with Directions

I agree at all times during the Fun Run to comply with the directions of anyone appointed or permitted by the Shire to organise the Fun Run, following all traffic and road laws including directions by Police, Shire staff and volunteers.

I acknowledge failure to do so may result in being removed from the Fun Run.

Holi powder (the colour)

Should you wish not to be thrown at with the coloured powder at the 5 colour stations, please surpass the stations in a wider curve and attendants will not throw powder at you.

The Holi powder is made from corn starch and should be removable from clothes by normal laundry.

The Shire of Yilgarn and/or Southern Cross CRC will not take responsibility for any damaged or discoloured clothing and recommend choosing the outfit for the day accordingly.

The coloured powder composition is "Corn Starch (99%) and Food Grade Dye (<1%). See below for an extract from the supplier's safety data sheet. A complete version can be viewed at the event or upon request.

I also know that, although at the event ahead signage might be provided, there could be traffic on the course route (including but not limited to bicycles, skateboards, baby joggers, roller skates or roller blades, animals, and personal music); therefore, I assume the risk of traffic. I also assume any other risks associated with partaking in this event including, but not limited to, falls, contact with other participants, and the effects of weather and conditions of the course, including the aggravation, acceleration or recurrence of an existing condition, contraction, aggravation or acceleration of a disease I understand I am solely responsible for my own safety while traveling to and from or participating in this event. I understand that if I leave any of my personal belongings at the baggage area, that the Shire of Yilgarn and/or Southern Cross CRC are not liable for any loss or damage.

Knowing these facts and in consideration of your acceptance of my entry, I hereby for myself, my heirs, executors, administrators, or anyone else who might sue on my behalf covenant not to sue, and waive, release, and discharge the sponsors or contributors to this event, any race officials, volunteers, the city and police agencies, their representatives successors or assignees from any and all claims of liability for death, personal injury, or property damage of any kind or nature whatsoever arising out of, or in the course of my participation.
